THESE ADVOCATES FOCUS ON THE INDIVIDUAL NEEDS OF EACH CHILD AND ADVOCATE FOR THOSE INTERESTS THROUGHOUT THE LEGAL AND CHILD WELFARE PROCESS. THIS PROGRAM IS AFFILIATED WITH THE COURT APPOINTED SPECIAL ADVOCATES OF NEW JERSEY, INC. AND THE NATIONAL CASA/GAL ASSOCIATION FOR CHILDREN.

THE NEW JERSEY SAFE BABIES COURT TEAM PROVIDES EVIDENCE-BASED AND HANDS-ON SUPPORT TO CHILDREN AGED 0-3 AND THEIR FAMILIES IN THE COURT SYSTEM. THE TEAM WORKS TO IMPROVE OUTCOMES FOR VERY YOUNG CHILDREN IN FOSTER CARE OR AT RISK OF REMOVAL FROM THEIR PARENT'S CARE. THE TEAM IS FOCUSED ON MINIMIZING TRAUMA AND ITS IMPACT ON EARLY DEVELOPMENT BY IMPROVING COLLABORATION BETWEEN THE JUDICIAL AND CHILD WELFARE SYSTEMS, WORKING TOGETHER TO SUPPORT YOUNG CHILDREN AND THEIR FAMILIES. NJSBCT IS AFFILIATED WITH ZERO TO THREE, THE NATIONAL RESOURCE CENTER FOR THE INFANT TODDLER COURT PROGRAM, FUNDED BY THE US DEPARTMENT OF HEALTH AND HUMAN SERVICES.
